- Knowledge of and ability to draw on a variety of theoretical frameworks in counselling (as counsellors frequently use a number of different approaches, no specific model of counselling or therapy approach is preferred)
- Ability to manage the counselling process (reviewing progress, planning future sessions, knowing when and how to end the counselling relationship).
- Ability to access accurate information and referrals.
- Thorough knowledge of human sexuality and sexual functioning, including an understanding of cultural differences and individual personal values, attitudes, and beliefs
- Ability to recognise and respect personal and professional limitations, and the role of counselling within SHQ.
- Demonstrated skilled approach to working with a range of community clients, including CALD, indigenous community, mental health issues, family violence issues and individuals at risk.
- A commitment to exploration of the counsellor's process in the counselling relationship.
- A commitment to attending regular supervision and to consult with peers and other professionals.
- Able to communicate effectively with a diverse range of people, to develop and maintain professional relationships, and share ideas successfully, including reporting succinctly and accurately. Able also to de-escalate strong negative emotion when necessary.
- Good computer skills.
- Excellent interpersonal skills and the ability to develop strong working relationships
- Ability to work autonomously as well as part of a team.
- Adaptable and open to new ideas.
- A commitment to ongoing personal and professional development.
